7. Reports

a. Head of School

Summer Break is finally here. The school year ended well. As usual we did have a couple of discipline issues with a few students. Most of this is due to testing being completed and students wanting school to be over sooner than later. Overall a normal ending of a school year.

We have submitted all necessary documents to the USDA for the application process that occurs in Washington during the early month of July. The submittal dated was escalated, however we did work with the Architect, the Appraiser, and our CPA. All of this information was asked of us at the very end of the process. We did have the cooperation of the USDA and our vendors to complete the process in a timely manner. Our "Thank you" to everyone. Now we wait and see, however if all goes our way we should have the money in August. The next phase will start by eliminating the bonds and bidding the construction work. More to follow.

We have started the summer maintenance of the facilities. There will be cleaning of the entire campus as well as an increase in painting of rooms, hallways, repairing computer inventory, updates on other equipment among normal duties. The school will have a welcome look when completed.

Summer Camp will start on June 26 and end on August 11. Brook Joyner and Devin Messick have been working diligently on preparing for another great year. Summer School will start on June 26 and end on Aug 3. Mrs. Brewer will be heading Summer School. Discover Camp will operate during the week of July 17 and July 24. Mrs. Hennessy and Mrs. Wood will be heading this Camp and we look forward to everyone's success this summer.

A Boy Scout from Troop 239 will work on the Eagle Scout Award by rebuilding the platform near the pond. We have accumulated over 100 bikes over the years and we are in the process of donating the entire fleet to kids groups, i/e Boys and Girls Club, YMCA, YWCA. If you know of any groups, please let me know.

We are in the process of hiring an 8th Grade Math Teacher, a World Culture/Language Teacher, and a Second Grade Teacher for the upcoming school year. We have received many applications for these positions. Interviews will take place in the very near future.

Overall we are on the Path to Achievement. Following this Path will make all of our students, families and staff successful.

b. Principal

We are fully enrolled with 231 applicants on the waiting list.

Special Education:

Our LEA Determination CAP for FFY 2014 final submission for June 30, 2017 has been submitted. We have also received our LEA Determination for Spring 2017, based upon FFY2015. We still fall into the Needs Assistance category based upon our special education population not meeting growth targets in grades 4-8, 7th grade special education participation below 95%, and Secondary Transition. Since the time this data has been collected, we have made changes in our Secondary Transition process and received training from the Department of Education. I anticipate next year's data to show Meets the Criteria for this indicator as our last Indicator 13 review showed we had met. The participation rate was such that we had a 7th grade student "opt out". With a small sample group one student had significant impact. We will continue to work on proficiency with our identified students.

ESY services will be provided by Mrs. Knorr-Hayden, Ms. Shiber and Ms. Nation for academics. Our vendors will provide Speech and OT services. Two students will receive ESY via Summer Camp. Twenty-nine students will be provided services for the six week period.

Promotion/Retention/Summer School:

Final grades were calculated for final determination on June 12th. All parents were contacted regarding summer school and retention. The numbers are below:

- 6 Retention
- 4 Summer school
- 1 Deciding on Summer School

Ms. Brewer is overseeing our summer school program as well as providing the service.

c. Director of Curriculum

The state testing window closed on June 1, 2017. Although Providence Creek Academy acknowledges that a small snapshot in the day of our students' life is poor measure for whole-child academic performance our teachers and students alike worked diligently to complete the

required state testing. The below data represent the achievement scores by subject matter and grade level.

The students at Providence Creek Academy scored at higher proficiency rates when compared with the state averages (at the time of writing this report) in all subjects tested and in all grades tested with the exception of fourth grade mathematics. Despite the positive results when compared with the state averages, Providence Creek Academy faculty and students have significant gains yet to be accomplished with roughly 40% of our students lacking ELA/Literacy proficiency and roughly 50% of our students lacking Mathematics proficiency. With the continuation of the research-based Eureka Math curriculum with math specialist support, the adoption of the Fountas and Pinnel research-based Scholastic Guided Reading program complete with professional learning session, and the inclusion of the Writing By Design K-8 program, PCA is poised to continue to see academic gains for our students, both in the classroom and on state required assessments.

The school year concluded with many wonderful authentic learning opportunities. All grade levels participated in service learning projects, fifth grade held their annual Wax Museum, third grade operated their successful Market Day. These are but a few examples of the exciting culminating learning activities that occurred for our PCA students.

Below is the Providence Creek Academy Discovery Camp 2017 flier. We are excited that teachers Tracey Hennessy and Joy Wood will be facilitating approximately 20 students' mission to the stars!
