- 1. **Call to Order**: The meeting was called to order at 6:06 pm

 - g. The cost(s) listed above do not include any road improvements from DelDOT. DelDOT is asking for a core test to be completed. Final authorization from DelDOT is required in order to submit for a construction permit. DelDOT has stated that they will provide a letter of no objection. CCC is recommending that the Board approve a parallel path to begin submitting for permits while waiting for final authorization from DelDOT.
 - h. CCC does not anticipate any delays in completing lower school renovations by the beginning of the school year.
 - i. Details were discussed regarding safety of students and crew during construction, including fencing, equipment, relocation of car rider line, and summer camp.

 - i. PCA has received approximately 94% of its funding and expects to receive 100% of funding.
 - ii. Minor Capital Improvement funding of \$75,000 was received, bringing PCA's carryover down 1.65 million.
 - iii. Expenditures are at approximately 43%, which also includes funds allocated for construction for Expansion Committee.
 - iv. The current transportation system is not working as it should, so PCA is exploring a new system. Funds for the current system are reimbursable.
 - v. Cafeteria department was reviewed and is running at plan.
 - vi. PCA is expected to end the fiscal year with approximately 1.6 in reserves, inclusive of costs for the expansion project.
 - vii. The Guaranteed Maximum Price Amendment Bid Results and Cost Summary for the Expansion Project was reviewed and discussed.
 - viii. P-card and bank statements were reviewed with no findings of note.

- i. DelDOT approval is on track. Mrs. Stouffer's recommendation is that Old Business A be amended for approval pending DelDOT's letter of no contest and turn lanes not to exceed \$150,000.
