- a. CBOC Committee: Chuck Mosher
 - i. PCA increased its contingency to \$393,823.38 which is approximately \$166,712.62 above the required contingency amount of \$227,111.26.
 - ii. The State Unit Formula (05213) increased to \$7,651,219.
 - iii. Enhanced MCI (10337) expected to receive the revenue for this in the coming months based on information received by the State of Delaware.
 - iv. Local District Funding has received more than the anticipated revenue by \$24,649.79 which brings Local District Funding receipts to \$1,301,557.98.
 - v. Unique Alternatives (05181) was added for \$259,940.10 for student alternative placement. PCA still expects to receive an additional \$100,000 as the local portion for this funding.
 - vi. PCA is 57.69% into the fiscal year and overall expenditures are at 51.15% which is approximately 6.54% under the actual percentage for this month.
 - vii. Last month PCA's expenditures were at 45.88%, which was 4.12% under the actual percentage, including unallocated.
 - viii. Family Care Benefits were added to the OEC section with a budget of \$1,500 based on the Delaware Paid Leave going into effect this month.

- ix. In the Transportation Department, expenditures are currently at 43.64%, which is 14.05% under the actual percentage for this month in the Charter Transportation (05177) budget.
- x. In the Cafeteria Department, expenditure is currently at 38.70%, which is 18.99% under the actual percentage for this month.
- xi. The PNC Bank Statements were reviewed for this month and show deposits of \$2,526.94 which includes a payment of \$600 for the Saints Classic Tournament and a payment of \$1,926.94 for business services provided to Bryan Allen Stevenson School of Excellence. These funds were withdrawn and deposited into the PCA state account as noted in the attached documentation.
